


German energy storage project subsidies





Overview

Germany is disbursing EUR 4.6 billion in subsidies for 23 projects for hydrogen production, transportation, and storage. The grants are awarded by the federal government and individual states, while beneficiary companies are to provide a total of EUR 3.3 billion of their own funds. Does Germany offer subsidies for battery storage systems?

2013, the German government declared it would offer direct subsidies for battery storage systems. These subsidies would be 30% of the total system cost and connected to the latest distributed solar systems of less than 30KW. This policy was extended to 2018.

What changes have been made to Bess projects in Germany?

The German legal framework for BESS projects is currently also in a process of changes: The German parliament adopted a comprehensive energy reform package on 31 January 2025, which includes relevant changes for BESS projects with the aim to further support the growth of storage capacities in Germany.

Is German battery storage a good investment?

German Battery Storage on a Ri. High and further increasing volatility of power prices due to the expansion of renewables on the one hand and significantly decreasing prices for battery cells in recent years on the other hand have led to a highly attractive market environment for battery storage (BESS) projects in Germany.

Can construction cost subsidies be charged for battery storage systems?

The Higher Regional Court of Düsseldorf left open the question of whether — and if so, how — construction cost subsidies may be charged for battery storage systems for grid connections above low voltage. However, the general direction of the ruling was in any case favorable for the battery storage system industry.



When will Bess energy reform come into force in Germany?


On January 31 2025, the German Parliament adopted a comprehensive energy reform package which includes, inter alia, the following changes for BESS projects which are expected to enter into force in March 2025:.

Are battery prices going down in Germany?

Within five years, battery prices have dropped by more than half in Germany, and there is no end in sight for further reductions. Forecasts business suggests that the total cost of an energy storage system should decline to 50-70% by 2035 due to design module advances and streamlined processes.
