Why is energy storage important in Italy?

In addition, electricity storage is critical to avoid congestion in the power grid since most of the renewable production originates in Southern Italy but is



consumed mostly in the north. Therefore, PNIEC also provides for the installation of new energy storage infrastructure with the aim of reaching 22.5 GW of installed storage capacity by 2030.
