

Somaliland exempts solar panels from customs duties





Overview

Many countries across the world have built up a policy framework which is aimed at supporting the development of renewable energy technologies.

Can a business import solar modules free of duty?

Under the Manufacturing and Other Operations in Warehouse Regulations (MOOWR), the CBIC allows businesses to import solar modules free of duty, manufacture solar projects, and generate power for domestic sales or exports, in a customs bonded warehouse. No duty is payable by businesses till the time the modules stay within the facility.

Somali Customs Tariff 310 Chapter 86 includes railway or tramway locomotives, rolling-stock and parts thereof; railway or tramway track fixtures and fittings and parts thereof; and mechanical (including electro-mechanical) traffic signalling equipment of all kinds.




