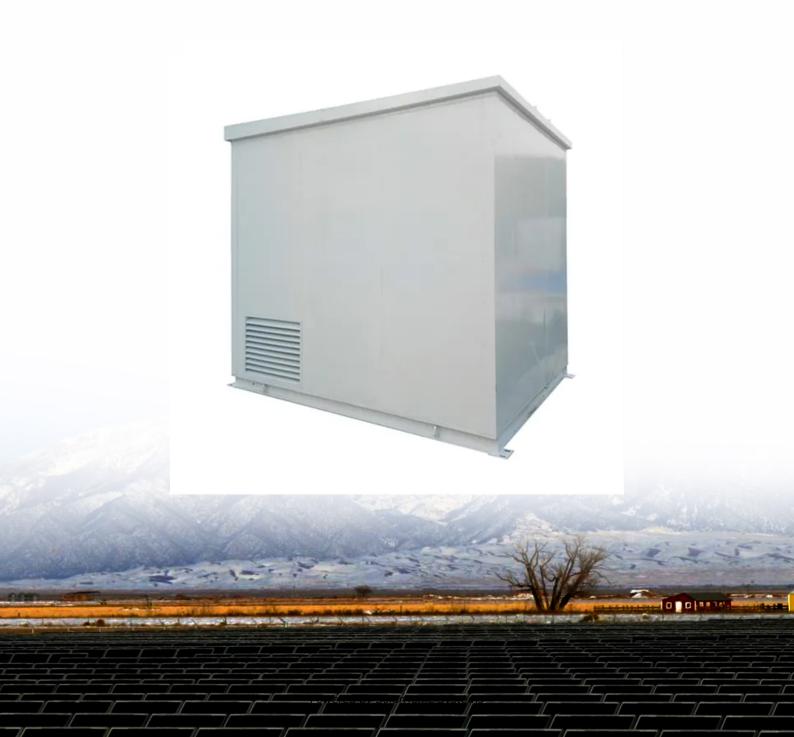


# What fire protection regulations do communication base station batteries follow



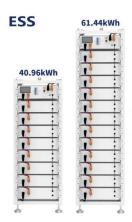


