

# Zimbabwe energy storage project approval requirements







#### **Overview**

What is "renewable energy" in Zimbabwe?

The NREP defines "renewable energy" as referring to "small hydro (equal to or less than 30MW), solar, wind, geothermal, biofuels and biomass and other such clean energy sources approved by the Ministry responsible for Energy in Zimbabwe".

Who is responsible for the energy sector in Zimbabwe?

The MOEPD has overall responsibility for the energy sector in Zimbabwe. It is responsible for policy formulation and implementation, an oversight role over the government-owned utilities (ZETDC and ZPC), ZRA jointly with Zambia and the activities of ZERA. It is also responsible for regional and international cooperation on renewable energy issues.

What are the requirements for a building contractor in Zimbabwe?

Before an engineering or building contractor starts work, they require consents and approvals from certain offices or departments. All engineers in Zimbabwe must be registered with the Engineering Council of Zimbabwe under the terms of the Engineering Council Act [Chapter 27:22] before they can perform any works.

Do engineers need to be registered in Zimbabwe?

All engineers in Zimbabwe must be registered with the Engineering Council of Zimbabwe under the terms of the Engineering Council Act [Chapter 27:22] before they can perform any works. Projects require the following approvals, which may be obtained by the contractor or the owner:.

How much does electricity cost in Zimbabwe?

A connection to the national electricity grid from the Zimbabwe Electricity Transmission and Distribution Company (ZETDC) for a minimum cost of approximately US\$632 in administration fees and US\$507 for a metre (to the



extent that no new wiring, meters and transformers require being purchased and installed otherwise the costs can exceed US\$1139.

Who can appoint a senior manager in Zimbabwe?

The ZIDA Act permits an investor to appoint, regardless of their nationality, any qualified individual as a senior manager, technical and operational expert or advisor with respect to the investment in accordance with the laws of Zimbabwe. Work permits would be required for such employees.


